

BIPS Faculty Members Completed Various Certification Courses

Dr. Sadia Ahmed⁽¹⁾, Dr. Zuneera Akram⁽²⁾, Dr. Muzammil Hussain⁽³⁾, and Ms. Aisha Noreen⁽⁴⁾ have completed the National Academy of Higher Education's (NAHE) online courses on "HEC's Policy on Sexual Harassment in HEIs" and "HEC's Policy on Students with Disabilities" in June 2021.

Dr. Zuneera Akram⁽²⁾ and Ms. Aisha Noreen⁽⁴⁾ completed a four-week online course in April 2021 on 'Analytical Understanding of the Regression Family via SPSS'. The course covered the fundamentals of regression analysis in this two-module-based course, including the conceptual understanding of components of regression analysis, assumptions, data handling, linear regression, and multiple linear regression.
